Pétanque Union Bois le Duc processes your personal data because you use our website <u>www.puboisleduc.nl</u> and/or because you provide this data to us yourself.

Participation in these tournaments and events automatically means that these images, - as well as results achieved during tournaments -, may be published on the website, whether or not supplemented with the first and last name of the person(s) concerned and the name of the association they represent.

### Special and/or sensitive personal data that we process

Our website does not intend to collect data about website visitors under the age of 16 unless they have permission from their parents or guardian. However, we cannot check whether a visitor is older than 16 years. We therefore advise parents to be actively involved in the online activities of their children, in order to prevent data about children from being collected without parental consent. ## For what purpose and on what basis we process personal data

Pétanque Union Bois le Duc processes your personal data for the following purposes:

- Sending newsletters, invitations to tournaments or other events related to the sport 'pétanque'.
- To be able to call or email you if necessary.
- Address details are noted for the purpose of targeted goods traffic (a.o.: lost and found).

### **Automated decision making**

Pétanque Union Bois le Duc does not take decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without involving a person (for example, an employee of Pétanque Union Bois le Duc).

### How long do we keep personal data

Pétanque Union Bois le Duc in principle stores your personal data for an indefinite period, but no longer than is strictly necessary to achieve the purposes for which your data is collected, such as sending newsletters, invitations to tournaments or other events related to the sport 'pétanque'.

### Sharing of personal data with third parties

Pétanque Union Bois le Duc does not provide your personal information to third parties. If Pétanque Union Bois le Duc deems this necessary, you will first be asked for your permission to do this.

#### **Facebook**

We use the Facebook social network icon on our website. This service is provided by Facebook Inc. However, a contact between you and Facebook will only be established if you actively click on the icon.

The processing of your personal data on Facebook is beyond our control. When you use Facebook, the platform operator usually stores cookies in your browser in which your usage behavior or information about your interests is stored for market research and advertising purposes. Since the services of the platforms can also be used without registration, it cannot be excluded that persons who are not registered on the respective platform will also be subject to data processing.

The processing of your personal data when you visit Facebook is based on our legitimate interests in our association activities. This also includes the presentation of our association to the outside world and the use of Facebook as an additional information and communication channel.

# View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Pétanque Union Bois le Duc. You also have the right to data portability. This means that you can submit a request to us to send the personal data we have about you in a computer file to you or another person or organisation mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data and / or request for cancellation of your consent or objection to the processing of your personal data to <a href="mailto:info@puboisleduc.nl">info@puboisleduc.nl</a>.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within 4 weeks.

Pétanque Union Bois le Duc would also like to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
